ADDENDUM**B1. Probable Cause Statement**

ON JULY 14, 2017 AT 1708 HOURS, PHOENIX POLICE OFFICERS RESPONDED TO A SUBJECT WITH A GUN AT 2025 WEST SHERMAN STREET. UPON THEIR ARRIVAL THEY OBSERVED TWO HISPANIC MALES ON THE FLOOR IN A PHYSICAL FIGHT INSIDE THE RESIDENCE. TOLD OFFICERS HE ARRIVED HOME AFTER WORK AND WHEN HE ENTERED THE HOME WALKED INTO THE KITCHEN AND WAS CONFRONTED BY HIS SON, IGNACIO ESTRADA, WHO WAS HOLDING A SHOTGUN AND SAID, DONT MOVE. GIVE ME YOUR CELL PHONE AND WALLET. IG-NACIO FIRED ONE ROUND FROM THE GUN AS DUCKED AND TACKLED IGNACIO. THE TWO WERE IN A PHYSICAL FIGHT FOR APPROXIMATELY 45 MINUTES. , THE MOTHER TO IGNACIO AND WIFE TO , ARRIVED HOME AND OBSERVED THE TWO IN A PHYSICAL FIGHT. TOLD IGNACIO HAD A GUN AND SHE CALLED 911. OBSERVED A BULLET STRIKE TO THE BEDROOM DOOR OF HER DAUGHTER. WHEN OFFICERS ENCINAS 9700 AND SARABIA 9693 ARRIVED, WAS OUTSIDE AND ADVISED THEM HER SON HAD A GUN AND TOLD THEM NOT TO SHOOT HIM AND HE WAS NOT RIGHT IN THE HEAD. OFFICERS -NAS AND ENTERED THE HOME AND IGNACIO AND WERE STILL IN A PHYSICAL FIGHT. THEY OBSERVED ON TOP OF IGNACIO AND IGNACIO WAS ON TOP OF A SHOT-GUN. OFFICER PUSHED THE GUN INTO THE LIVING ROOM AND OFFICER PULLED OFF OF IGNACIO. OFFICER THEN TOOK IGNACIO INTO CUSTODY. INVESTIGATORS ADVISED IGNACIO OF HIS MIRANDA WARNINGS AND CONDUCTED AN INTERVIEW WITH HIM. DURING THE INTERVIEW, IGNACIO ADMITTED TO PLANNING ON KILLING HIS EN-TIRE FAMILY FOR THE LAST YEAR DUE TO A 20,000 LOAN HE GAVE TO HIS MOTHER AND FATHER. LAST NIGHT, IGNACIO TOOK THE CAR KEYS FROM HIM HIS BROTHERS, , BED AND WENT TO CAR AND REMOVED THE 12 GAUGE SHOTGUN FROM THE TRUNK AND HID IT IN THE BACKYARD UNTIL HIS FAMILY WAS ASLEEP. ABOUT 1000 PM IG-NACIO WENT OUTSIDE AND BROUGHT THE GUN INTO THE HOUSE AND HID IT IN HIS ROOM. IGNACIO WOKE UP TWO DIFFERENT TIMES TODAY AND THOUGHT ABOUT TYING UP HIS SISTER, , OR SHOOTING HER. IGNACIO DECIDED HE WAS GOING TO SHOOT SO SHE WOULD NOT BE ABLE TO CALL THE POLICE AFTER HE SHOT AND KILLED THE REST OF HIS FAMILY. IGNACIO WAS IN HIS ROOM AND REMOVED THE BIRDSHOT AND LOADED THE SHOTGUN WITH MULTIPLE ROUNDS OF SLUGS BECAUSE THEY DO MORE DAMAGE. IGNACIO THEN STOOD AND FIRED IN THE DIRECTION OF ROOM THREE TO FOUR TIMES. AFTER THIS, WAS STILL ALIVE BECAUSE IGNACIO HEARD HER MOANING. IGNACIO WALKED OUT OF HIS ROOM TO THE LIVING ROOM AND FIRED AN ADDITIONAL ROUND. IGNACIO WALKED DOWN THE HALLWAY AND FIRED AGAIN INTO THE ROOM. HE TRIED TO OPEN BEDROOM DOOR, BUT THE DOOR WAS LOCKED. IGNACIO WAITED IN HIS ROOM WITH THE DOOR CRACKED FOR HIS FATH-ER, , TO COME HOME FROM WORK. IGNACIO WAS GOING TO TAKE HIS FATHERS WAL-LET, DEBIT CARD AND PIN NUMBER AND THEN SHOOT AND KILL HIS FATHER. WHEN WALKED INTO THE HOUSE IGNACIO POINTED THE SHOTGUN AT HIM AND DEMANDED HIS WALLET AND DEBIT CARD. IGNACIO ADMITTED HE PLANNED ON SHOOTING HIS FATHER IN THE HEAD, BUT WHEN HE PULLED THE TRIGGER THE GUN MALFUNCTIONED. IGNACIO RACKED THE SLIDE PULLED THE TRIGGER A SECOND TIME AND THE GUN WENT OFF BUT DID NOT STRIKE HIS FATHER. GRABBED THE GUN AND THE TWO WERE IN A PHYSICAL FIGHT/STRUGGLE FOR ABOUT THIRTY MINUTES. IGNACIOS MOTHER ARRIVED HOME FROM WORK AND CALLED THE PO-LICE AFTER HEARING AND SEEING HER HUSBAND AND IGNACIO IN A FIGHT. IGNACIO ADMIT-TEd HE WAS GOING TO SHOOT AND KILL BOTH HIS MOTHER AND BROTHER AFTER TAKING THEIR MONEY. IGNACIO SAID HE WAS BOTH AIMING AND SHOOTING BLIND WHEN HE SHOT IN-

TO ROOM. IGNACIO SAID HE WAS NOT UNDER A DOCTORS CARE AND NOT CURRENTLY ON ANY MEDICATIONS. HE WAS DIAGNOSED WITH DEPRESSION A COUPLE YEARS AGO. CHAR-GING REQUEST ONE COUNT FIRST DEGREE MURDER FOR KILLING ONE COUNT ATTEMPTED FIRST DEGREE MURDER FOR ATTEMPTING TO KILL ONE COUNT ATTEMPTED FIRST DEGREE MURDER FOR PLANNING TO KILL HIS MOTHER, ONE COUNT ATTEMPTED FIRST DEGREE MURDER FOR PLANNING TO KILL HIS BROTHER, ONE COUNT ARMED ROBBERY AGAINST ONE COUNT AGGRAVATED AS-SAULT AGAINST ONE COUNT KIDNAPPING AGAINST ONE COUNT BURGLARY FROM VEHICLE, A RECORDS CHECK REVEALED IGNACIO HAD 3 WARRANTS FOR HIS ARREST. THEY WERE VERIFIED AS ACTIVE BY PHOENIX I BUREAU STAFF
