## **HB 2436**

AN ACT

APPROPRIATING MONIES TO THE DEPARTMENT OF ADMINISTRATION.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appropriation; January 8 memorial; matching  
3 monies; review; exemption

4 A. The following sums are appropriated from the state general fund  
5 in each of the following fiscal years to the department of administration  
6 for distribution to a nonprofit organization that is exempt from federal  
7 income taxation under section 501(c) of the internal revenue code for  
8 construction of a January 8 memorial that honors the victims of the  
9 January 8, 2011 tragedy in Tucson:

- 10 1. In fiscal year 2017-2018, \$500,000.
- 11 2. In fiscal year 2018-2019, \$500,000.
- 12 3. In fiscal year 2019-2020, \$500,000.
- 13 4. In fiscal year 2020-2021, \$500,000.
- 14 5. In fiscal year 2021-2022, \$500,000.

15 B. Monies from each appropriation made in subsection A of this  
16 section may not be distributed in that fiscal year until a matching amount  
17 of monies from sources other than this state of gifts, grants and  
18 donations has been collected by the nonprofit organization for the  
19 January 8 memorial. Before distributing the appropriation each fiscal  
20 year, the department of administration shall submit a report of the scope,  
21 design, construction progress and estimated cost of the January 8 memorial  
22 and a detailed, cumulative accounting of the matching amounts required by  
23 this subsection to the joint committee on capital review for its review  
24 pursuant to section 41-1252, Arizona Revised Statutes.

25 C. Pursuant to section 35-142.01, Arizona Revised Statutes, if the  
26 monies appropriated in subsection A of this section are subject to  
27 reimbursement in whole or in part from federal monies, the federal monies  
28 shall be deposited in the state general fund.

29 D. The appropriations made in subsection A of this section are  
30 exempt from the provisions of section 35-190, Arizona Revised Statutes,  
31 relating to lapsing of appropriations until June 30, 2023.

32 Sec. 2. Conditional enactment; notice

33 A. This act does not become effective unless on or before June 30,  
34 2023 the United States secretary of the interior establishes a January 8  
35 national memorial in Tucson as an affiliated area of the national park  
36 system.

37 B. The director of the Arizona legislative council shall notify in  
38 writing the director of the joint legislative budget committee and the  
39 director of the department of administration on or before June 30, 2023  
40 either:

- 41 1. Of the date on which the condition was met.
- 42 2. That the condition was not met.

43 Sec. 3. Delayed repeal

44 This act is repealed from and after December 31, 2023.
