ON 03/21/2017 AT APPROXIMATELY 0510 HOURS, S1 COMMITTED KIDNAPPING AND AGGRAVATED ASSAULT WHEN HE USED HIS LEFT ARM TO GRAB V1 FROM THE REAR PUTTING HER IN A REAR NAKED CHOKE HOLD AND VERBALLY ORDERING HER TO GET ON THE GROUND. S1 PLACED A HARD OBJECT AGAINST V1'S RIGHT TEMPLE ON HER HEAD AND HELD THE OBJECT AGAINST HER HEAD FOR THE DURATION OF HIS PHYSICAL DETENTION OF V1 WHICH LASTED FOR A PERIOD OF APPROXIMATELY 20 SECONDS. THE CRIME OCCURRED NEAR 7500 W MOUNTAIN VIEW ROAD PEORIA, AZ 85345.

V1 FELT AFRAID THAT THE HARD OBJECT AGAINST HER HEAD WAS A WEAPON. SHE SCREAMED LOUDLY AND WAS SO AFRAID SHE ADVISED SHE DOESN'T REMEMBER HOW SHE ESCAPED S1'S REAR NAKED CHOKE HOLD. V1 RAN FROM THE CRIME SCENE AS FAST AS SHE COULD CAUSING AN ASTHMA ATTACK FROM HER PHYSICAL RESISTANCE AND ANXIETY. V1 LATER IDENTIFIED S1 IN A ONE ON ONE OF THE SUSPECT. WHEN SHE SAW THE SUSPECT AGAIN DURING THE ONE ON ONE IDENTIFICATION, THE ESCORTING OFFICER ADVISED THE V1 BECAME EMOTIONAL AND SOUNDED AFRAID WHEN POSITIVELY IDENTIFYING S1.
