B. PROBABLE CAUSE STATEMENT

1. Please summarize and include the facts which establish probable cause for the arrest: ON 02/16/2017 AT APPROXIMATELY 0235 HOURS, DPS TROOPERS OBSERVED A VEHICLE TRAVELING WRONG WAY ON THE US 60 FOR SEVERAL MILES. THE VEHICLE WAS TRAVELING EASTBOUND IN THE WESTBOUND LANES OF TRAFFIC. TWO TROOPER ATTEMPTED TO USE THEIR PATROL VEHICLES TO STOP THE WRONG WAY DRIVER AND WERE UNSUCCESSFUL. SUBSEQUENTLY BOTH TROOPERS COLLIDED THEIR VEHICLES IN AN EFFORT TO STOP THE WRONG WAY DRIVER. BOTH TROOPERS WERE NOT INJURED. INTIAL 911 CALLERS REPORTED THE VEHICLE TRAVELING SOUTHBOUND SR 51 IN THE NORTHBOUND LANES OF TRAFFIC. SEVERAL 911 CALLERS REQUESTED THEIR RIGHTS IN THIS MATTER FOR ENDANGERMEN- T. IT WAS ESITMATED THE DRIVER TRAVLED 20 MILES WRONG WAY ON THREE DIFFERENT HIGHWAYS. THE VEHICLE WAS SPIKED ON US 60 AND EVENTUALLY CAME TO A STOP WRONG WAY AT MP 178. THE DRIVER WAS TAKEN INTO CUS- TODY. I DETECTED A STRONG ODOR OF ALCOHOLIC BEVERAGE EMITTING ON HER BREATH AS I DETAINED HER. SHE STATED SHE SHOULD NOT HAVE BEEN DRIVING AND WAS DRUNK. TROOPER MCLEMORE CONDUCTED HGN ON THE DRIVER WHICH REVEALED 6 CLUS OF HGN AND VERTICAL NYSTAGMUS. THE DRIVER WAS ARRESTED FOR EXTREME DUI AND ENDANGER- MENT. THE AFOREMENTIOEND STATED SHE HAD MARIJUANA IN THE VEHICLE AFTER SHE WAS ARRESTED. DURING A VEHCLC SEARCH OF THE VEHICLE, MARIJUANA AND DRUG PARAPHERNALIA WAS LOCATED IN THE VEHICLE. WHILE THE DRIVER WAS BEING PROCESSED DUI AT DPS STATION, THE AFORMENTIONED STRUCK A TROOPER IN THE CHEST WITH A CLOSED FIST. WHILE ATTEMPTING TO DETAIN THE DEFED- NANT, SHE THEN STRUCK ANOTHER TROOPER IN THE CHIN WITH A CLOSED FIST. THE DRIVER WAS COMBATIVE AND UN- COOPERATIVE. A WARRANT WAS SERVED TO THE DEFENDANT FOR A BLOOD DRAW. DURING THE BLOOD DRAW THE DEFEND- ANT WAS UNCOOPERATIVE AND DID NOT COMPLY WITH A COURT ORDER FOR THE BLOOD DRAW. SHE STATED SHE WAS GOING TO RESIST WHILE THE TROOPER CONDUCTED THE
