<u>ADDENDUM</u>

B1. Probable Cause Statement

ON 04/30/2017 AT APPROXIMATELY 1226 HOURS, MARICOPA COUNTY SHERIFF'S OFFICE COM-MUNICATIONS RECEIVED A 9-1-1 CALL FROM KARL JAMES LEPAK STATING HE ACCIDENTALLY SHOT HIS WIFE, . WAS SHOT IN THE CHEST DURING AN ARGUMENT WHICH WAS OCCURRING AT THEIR RESIDENCE LOCATED AT WAS SUBSEQUENTLY TRANSPORTED BY HELICOPTER TO JOHN C. LINCOLN HOSPITAL WITH A LIFE-THREATENING INJURY DESCRIBED AS A GUNSHOT ENTRY WOUND TO THE RIGHT SIDE OF HER CHEST AND EXIT WOUND FROM HER BACK, THROUGH THE SHOULDER BLADE. COMMUNICATIONS DISPATCHER NOTED IN THE CALL THAT A FEMALE COULD BE HEARD STATING, "MY HUSBAND SHOT ME." DURING THE CALL TO 9-1-1, KARL STATED AGAIN, "I ACCIDENTALLY SHOT HER." DURING THE INITIAL INVESTIGATION, I LEARNED KARL AND WERE INVOLVED IN A PHYSICAL DOMESTIC VIOLENCE DISPUTE WHICH BEGAN SOMETIME IN THE EARLY MORNING HOURS OF 04-30-17. DURING THAT INCIDENT, ALLEGED SHE WAS STRUCK MULTIPLE TIMES IN THE HEAD WITH A METAL WATER BOTTLE. ON 04-30-17, I RESPONDED TO THE LISTED ADDRESS IN REFERENCE TO BEING SHOT IN THE CHEST BY KARL WITH A 9MM SEMI-AUTOMATIC HANDGUN. DETECTIVE D. BEAVER 1499 RESPONDED TO THE HOSPITAL WHERE MEDICAL PERSONNEL HAD A GUNSHOT WOUND TO HER UPPER RIGHT BREAST, LACERATIONS TO HER ADVISED HIM HEAD, AND IT APPEARED SHE HAD BEEN CHOKED DUE TO REDNESS AROUND HER THROAT. DURING MIRANDIZED INTERVIEW WITH KARL, HE TOLD ME HIT AT HIM WITH THE METAL WATER BOTTLE WITH APPROXIMATELY 4-5 GLANCING BLOWS TO THE ARMS. KARL NEVER SAID HE WAS HIT IN A VITAL AREA. KARL STATES HE WAS HIT 4-5 TIMES BEFORE HE "SNAPPED." ACCORDING TO KARL, HE TOOK TO THE GROUND WHERE HE STRADDLED HER BACK WHILE SHE WAS ON HER STOMACH. KARL STATED HE WAS TIRED OF HER CUSSING AT HIM. ACCORDING TO HIM SHE YELLS, CUSSES AT HIM AND CALLS HIM NAMES WHEN SHE IS DRUNK. WHEN KARL "SNAPPED" HE GRABBED THE METAL WATER BOTTLE AND INTENTIONALLY HIT HER IN THE BACK OF THE HEAD BECAUSE "HER FACE WAS BEAUTIFUL." KARL ADMITTED TO HITTING HER WITH METAL WATER BOTTLE. KARL STATED HE PUT HIS ARM AROUND NECK WITH THE INTENTION OF CHOKING HER TILL SHE PASSED OUT BECAUSE SHE WOULD NOT STOP YELLING AT HIM. AFTER HE HAD HIT HER WITH THE BOTTLE TILL SHE WAS BLOODY AND ATTEMPTED TO CHOKE HER TO UNCONSCIOUSNESS, HE ATTEMPTED TO CLEAN THE BLOOD WITH HYDROGEN PEROXIDE AND CARPET CLEANER. THAT NIGHT, IN THE BED AND KARL SLEPT ON THE COUCH. KARL TOLD ME GOT UP DURING THE MORNING AND WASHED THE METAL WATER BOTTLE BEFORE GOING BACK TO BED. WHEN KARL AWOKE, HE WENT TO THE BEDROOM AND LIED ON THE BED WITH HE WAS LAYING ON HIS RIGHT SIDE AND SHE ON HER LEFT; FACING EACH OTHER. KARL TOLD ME THAT HE WAS STROKING HER HEAD WHEN HIS HAND FELT A GUN ON THE SIDE OF THE PILLOW. WHEN HE GRABBED THE GUN, KARL WAS SHOCKED. HE TOLD ME BECAME AGITATED. SAID, "GIVE ME THAT!" AS KARL PULLED THE GUN AWAY FROM , KARL KARL TOLD ME PULLED THE TRIGGER. WHEN THE GUN WENT OFF, IT HIT IN THE RIGHT BREAST. KARL AND HAVE BEEN MARRIED APPROXIMATELY 6 YEARS AND HAVE 2 CHILDREN TOGETHER.
