

### ADDENDUM

B1. Probable Cause Statement

ON 4-6-18 AT APPROXIMATELY 0444 HOURS, MESA POLICE DEPARTMENT OFFICERS WERE DIS-IN MESA ARIZONA REGARDING A FIGHT. ONCE ON SCENE THE PATCHED TO RESPONDING OFFICERS LEARNED THAT AND , MOTHER AND DAUGH-TER, ARRIVED AT THEIR RESIDENCE BY CAR AND PARKED IN THE CARPORT. AS THEY WERE ATTEMPTING TO UNLOCK THE DOOR TO THE RESIDENCE, A SUSPECT RAN UP TO THEM FROM THE STREET. THE SUSPECT WAS WEARING DARK CLOTHING, A STOCKING MASK, AND CARRYING A CANISTER OF PEPPER SPRAY, CAPSICUM SPRAY. THE SUSPECT HELD THE CANISTER UP AND AS HE APPROACHED THE TWO VICTIMS, HE BEGAN TO SPRAY THEM BOTH IN THEIR FACES. THE SUSPECT PUNCHED IN THE BACK OF HER HEAD AND WALKED PAST HER TOWARDS THE SUSPECT THEN GRABBED PURSE THAT SHE HAD ON HER LEFT SHOULDER. THE SUSPECT AND BEGAN TO STRUGGLE OVER THE PURSE. AS THE SUS-PECT WAS STRUGGLING WITH , THE SUSPECT FORCED THE VICTIM DOWN TO THE GROUND WHILE STILL TRYING TO PULL THE PURSE AWAY FROM HER. AS WAS STRUG-GLING WITH THE SUSPECT, REACHED DOWN AND SAID, "IS THAT DAVID" PULLED THE STOCKING MASK OFF THE SUSPECTS FACE. RECOGNIZED THE SUSPECT AS ONE OF FRIENDS. THEN COULD SEE THE SUSPECTS FACE AND RECOGNIZED HIM AS DAVID GARCIA. HAS KNOWN DAVID GARCIA FOR APPROXIMATELY 18 MONTHS. GARCIA STOOD UP AND BEGAN TO PULL ON THE PURSE. GARCIA WAS DRAGGING ON THE GROUND AS SHE STRUGGLED TO HOLD ONTO THE PURSE. GARCIA EVENTUALLY REACHED INTO THE PURSE AND REMOVED A WALLET AND A DAY PLANNER THAT CONTAINED APPROXIM-ATELY \$1000.00. ONCE GARCIA HAD THE WALLET AND DAY PLANNER HE RAN AWAY EAST ON 5TH STREET. HAD MINOR INJURIES FROM THE STRUGGLE. THE INJURIES WERE AND PHOTOGRAPHED. A PHOTO LINEUP WAS MADE THAT INCLUDED A PHOTO OF DAVID GARCIA AND FIVE OTHER RANDOMLY GENERATED PHOTOS. DAVID GARCIA'S PHOTO WAS IN POSITION

3. WERE SHOWN THE PHOTO LINEUP SEPARATELY. BOTH AND AND SELECTED GARCIA'S PHOTO AND SAID HE WAS THE PERSON INVOLVED IN THE INCID-ENT. GARCIA WAS LOCATED AT HIS RESIDENCE AT IN MESA AZ AND TAKEN INTO CUSTODY. GARCIA WAS TRANSPORTED TO THE MESA PD STATION LOCATED AT 130 N ROBSON AND PLACED IN AN INTERVIEW ROOM. GARCIA WAS ADVISED OF HIS MIRANDA RIGHTS AND SAID HE UNDERSTOOD. AT FIRST GARCIA DENIED BEING AT RESID-ENCE, BUT DID EVENTUALLY ADMIT THAT HE WAS THERE. GARCIA DENIED TAKING ANYTHING FROM AND DENIED BEING INVOLVED IN ANY PHYSICAL ALTERCATION. PROBABLE CAUSE WAS ESTABLISHED TO CHARGE GARCIA WITH ARS 13-1902A ROBBERY FOR TAKING ITEMS BY FORCE AND ARS 13-1203A1 ASSAULT FOR STRIKING AND CAUSING INJURIES FROM TO HER. GARCIA WAS BOOKED INTO THE MESA PD JAIL.
