B1. Probable Cause Statement

ON OCTOBER 22, 2017, AT APPROXIMATELY 0800 HOURS, AZ DPS TROOPER [REDACTED] 10200, CONDUCTED A TRAFFIC STOP ON A 1997 GOLD HONDA FOUR DOOR SEDAN FOR SPEED IN THE AREA OF SOUTHBOUND I-17 AND MILEPOST 244. THE VEHICLE WAS BEARING A NEW MEXICO LICENSE PLATE " ". AS THE TROOPER APPROACHED THE VEHICLE, HE WAS INFORMED BY OPERATIONAL COMMUNICATIONS (OPCOMM) THE VEHICLE WAS REPORTED STOLEN. TROOPER [REDACTED] ATTEMPTED TO GIVE VERBAL COMMANDS TO THE OCCUPANTS OF THE VEHICLE. THE VEHICLE THEN FLED THE AREA HEADING SOUTH. TROOPER [REDACTED] PURSUED THE VEHICLE IN HIS FULLY MARKED PATROL VEHICLE WITH HIS EMERGENCY LIGHTS AND SIRENS ACTIVATED. AS THE HONDA SEDAN PASSED DPS TROOPER [REDACTED] FULLY MARKED PATROL VEHICLE IN THE AREA OF I-17 AND MILEPOST 240, A HISPANIC MALE LEANED OUT OF THE FRONT PASSENGER WINDOW AND FIRED APPROXIMATELY ONE SHOT FROM A REVOLVED-STYLE HANDGUN AT TROOPER [REDACTED]. TROOPERS CONTINUED TO PURSUE THE HONDA SEDAN. IN THE APPROXIMATE AREA OF MILEPOST 240 THROUGH 238, THE FRONT MALE PASSENGER FIRED APPROXIMATELY TWO TO FOUR MORE SHOTS AT THE PURSUING TROOPERS, STRIKING ONE OF THEIR PATROL VEHICLES. TROOPERS PURSUED THE VEHICLE SOUTH ON I-17 TO THE STATE ROUTE 303. THE VEHICLE EXITED, THEN RE-ENTERED THE I-17 AND HEADED NORTHBOUND UNTIL THE VEHICLE SUDDENLY EXITED AT CAREFREE HIGHWAY. THE HONDA SEDAN HEADED EAST AND TROOPERS LOST SIGHT OF THE VEHICLE. THE VEHICLE WAS LOCATED ABANDONED IN THE BACK OF THE ALBERTSONS GROCERY STORE LOCATED [REDACTED] WEST CAREFREE HIGHWAY, PHOENIX, ARIZONA, AND SECURED IN THE SAME LOCATION. VIDEO CAMERA FOOTAGE OBTAINED FROM DESERT DONUTS LOCATED NEXT TO THE ALBERTSONS SHOWED A FEMALE SUBJECT EXITING THE FRONT DRIVER SEAT OF THE SEDAN. THE VIDEO ALSO SHOWED A HISPANIC MALE EXITING THE FRONT PASSENGER SEAT OF THE SEDAN WITH A HANDGUN IN HIS RIGHT HAND. BOTH SUBJECTS FLED THE AREA. A WITNESS AT THE 4 SONS FOOD STORES LOCATED AT [REDACTED] WEST CAREFREE HIGHWAY STATED A MALE MATCHING THE DESCRIPTION OF THE MALE SUBJECT THAT FLED THE SEDAN CONFRONTED HER AND OFFERED HER ONE MILLION DOLLARS TO DRIVE HIM OUT OF THE AREA. THE WITNESS REFUSED AND WAS ABLE TO CAPTURE A PICTURE OF THE MALE WITH HER CELL PHONE AND PROVIDED THE PICTURE TO TROOPERS. ADDITIONAL WITNESSES OBSERVED THE MALE AND FEMALE SUBJECT ENTER THE HOT BAGELS AND DELI RESTAURANT LOCATED AT 34640 NORTH NORTH VALLEY PARKWAY, PHOENIX, ARIZONA. THE MALE WAS OBSERVED CARRYING A BACKPACK. AT APPROXIMATELY 0904 HOURS, BOTH THE MALE AND FEMALE SUBJECT WERE TAKEN INTO CUSTODY BY MARICOPA COUNTY SHERIFF'S OFFICE DEPUTIES. SEVERAL WITNESSES FROM THE 4 SONS FOOD STORE WERE BROUGHT TO THE FRONT OF THE DELI AND POSITIVELY IDENTIFIED THE TWO AS THE SUBJECTS THAT APPROACHED THEM ASKING FOR RIDES. BOTH SUBJECTS ALSO FIT THE DESCRIPTION OF THE SUBJECT SEEN FLEEING FROM THE HONDA SEDAN IN THE BACK OF THE ALBERTSONS. THE MALE SUBJECT WAS LATER IDENTIFIED AS RAY RUDY SAUCEDO WITH A DATE OF BIRTH OF [REDACTED]. THE FEMALE SUBJECT WAS IDENTIFIED AS TIFFANY AVALOS WITH A DATE OF BIRTH OF [REDACTED]. DETECTIVES LOCATED A HANDGUN ABANDONED IN A TRASHCAN IN FRONT OF THE 1ST TRAMONTO CLEANERS LOCATED AT 3134 WEST CAREFREE HIGHWAY SUITE A1, APPROXIMATELY 100 YARDS FROM WHERE THE SUSPECTS FLED FROM THE HONDA, AFTER DETECTIVES FOLLOWED A SUSPECTED PATH OF TRAVEL DETECTED BY A POLICE CANINE. A CRIMINAL HISTORY REPORT REVEALED SAUCEDO IS CURRENTLY ON PROBATION FOR POSSESSION OF DANGEROUS DRUGS AND PARAPHERNALIA AND ALSO HAS PRIOR FELONY CONVICTIONS FOR POSSESSION OF DANGEROUS DRUGS AND PARAPHERNALIA, WITH NO EVIDENCE THAT ANY RIGHTS HAVE BEEN RESTORED SINCE THOSE CONVICTIONS FIRST WERE ISSUED. MARICOPA COUNTY PROBATION WAS CONTACTED AND AN ACTIVE PROBATION WARRANT
