B1. Probable Cause Statement

MEMBERS OF THE PHOENIX POLICE DEPARTMENT DETERMINED THE LISTED OFFENSES OCCURRED BETWEEN MARCH 7, 2017 AND JULY 12, 2017, AND THERE IS PROBABLE CAUSE HEREIN THAT ARTICULATES JARRELL STEPHENS COMMITTED ALL OF THE LISTED OFFENSES. ALL OF THE LISTED OFFENSES OCCURRED WITHIN THE CITY OF PHOENIX, COUNTY OF MARICOPA, AND STATE OF ARIZONA. WASTE MANAGEMENT MARCH 7TH, 2017 ON MARCH 7, 2017, AT 1836 HOURS, A MASS SHOOTING THREATS WAS POSTED WITH CRAIGSLIST POSTING ID 6035417132 FROM USER ID 148866654 WITH EMAIL [REDACTED] AND CELL PHONE NUMBER [REDACTED], WHICH STATED CANT WAIT TO RUSH IN THE PLACE WITH MY ASSAULT RIFLE AND SLAUGHTER AS MANY PEOPLE AS POSSIBLE. LETTING ME GO WAS A BIG MISTAKE.. YOU F [REDACTED] ARE DEAD. THAT B [REDACTED] IS A FAT, GREASY PERVERTED PIECE OF S [REDACTED] WHO SEXUALLY HARASSES ANY DECENT LOOKING WHITE FEMALE...AND THEY LET HIM GET AWAY WITH IT HE IS THE FIRST ONE TO GET SHOT IN THE HEAD. CANT WAIT TO BRING THE BLOODSHED AND MAYHEM. MARK MY WORDS PHOENIX AZ 85021. THE POST DISPLAYED A PICTURE OF THE FRONT OF THE WASTE MANAGEMENT CALL CENTER WITH A PICTURE OF A BLACK RIFLE NEXT TO IT. A FOLLOW UP POST FROM USER ID 148866654 AND EMAIL [REDACTED] AND CELL PHONE [REDACTED] WAS MADE ON MARCH 8, 2017 AT 1450 HOURS STATING HA, DUDE RIGHT. I TOTALLY DISAGREE. I CON-FIRMED WITH LOCAL SOURCES. THE PHOENIX PD CANT PATROL THE BUILDING ALL DAY. I BET MY GOVERNMENT SALARY AS SOON AS THE COPS LEAVE THE GUNMEN OR GUNMAN WILL JUST BOGART HIS WAY IN. THEIR BUILDING DOESNT EVEN HAVE SECURITY FOR CRYING OUT LOUD. THATS A MASSSHOOTERS WET DREAM. PREVENTION IS KEY. ONCE THESE THREATS WERE MADE PUBLIC SEVERAL EMPLOYEES MISSED WORK OUT OF FEAR A MASS SHOOTING WOULD TAKE PLACE. AFTER THE THREATS WERE DISCOVERED BY A CONCERNED CITIZEN ON CRAIGSLIST SEVERAL OFFICERS RESPONDED TO THE AREA. OFFICERS WERE ASSIGNED TO SPEAK WITH VICTIMS AND WITNESSES WHILE OTHER OFFICERS WERE ASSIGNED TO WATCH THE BUILDING AND THE AREA NEAR THE BUILDING. THE PHOENIX POLICE DEPARTMENT USED SEVERAL RESOURCES WHEN THESE THREATS WERE MADE. WASTE MANAGEMENT HAD TO HIRE SEVERAL PHOENIX POLICE OFFDUTY PERSONNEL TO SECURE THE BUILDING OVER THE NEXT SEVERAL MONTHS. THE PHOENIX POLICE DEPARTMENT CONTACTED A TERRORISM LIAISON OFFICER WHO BEGAN LOOKING INTO THE THREATS. WITH THE ASSISTANCE OF AN ANALYST FROM THE ARIZONA DEPARTMENT OF PUBLIC SAFETY, INFORMATION WAS OBTAINED FROM THE CRIAGSLIST POST IDENTIFYING USER ID 148866654. THE EMAIL [REDACTED] AND CELL PHONE NUMBER [REDACTED] WAS LISTED IN CONNECTION TO USER ID 148866654 UNDER CUSTOMER SUBSCRIPTION INFORMATION AND BOTH RELATED TO JARRELL STEPHENS IN PREVIOUS PHOENIX POLICE REPORTS. WASTE MANAGEMENT JULY 12, 2017 ON JULY 12, 2017 AT 1430 HOURS, ANOTHER MASS SHOOTING THREATS WAS POSTED WITH CRAIGSLIST POSTING ID 6216710605 FROM USER ID 148866654 WITH EMAIL [REDACTED] AND CELL PHONE NUMBER [REDACTED] AGAINST WASTE MANAGEMENT EMPLOYEES. THE THREATS POSTED ON CRAIGSLIST STATED, THIS COMPANY EPITOMIZES INCOMPETENCE AT THE HIGHEST DEGREE. I CANNOT WAIT FOR MY FRIEND TO BADGE ME INTO THE BUILDING BY ACCIDENT, SO I CAN GUN DOWN ALL THE MANAGERS I CAN FIND. I WILL EXTERMINATE THOSE C [REDACTED] S [REDACTED] JUST

LIKE THE PESTILENT ROACHES THAT THEY ARE. MY PURCHASED ASSAULT RIFLE WILL MAKE THE BODY COUNT EXTREMELY HIGH, AND ESPECIALLY WITH THE EXPANDABLE CLIPS AND HOL-LOWPOINT ROUNDS I HAVE IN MY POSSESSION. ANYONE WHO IS DUMB ENOUGH TO STOP ME WILL BE IN A BODY BAG ON HIS OR HER WAY TO THE LOCAL MORGUE. HIT LIST 1. GAT MS PIGGY2. NASTY GRANDMA3. SMALL DICKED WHITE GUY4. ANY EMPLOYEE WHO I FEEL LIKE SHOOTING THIS POSTING WAS DISCOVERED BY A CITIZEN WHO THEN CALLED THE PHOENIX POLICE DEPARTMENT TO REPORT IT. ONCE AGAIN SEVERAL OFFICERS RESPONDED TO WASTE MANAGEMENT. SEVERAL OFFICERS WERE USED TO SECURE THE AREA AND THE BUILDING. OFFICERS WERE USED FOR HOURS TO INVESTIGATE THE THREATS BY SPEAKING WITH MANAGEMENT AND OTHER EMPLOYEES. THE MANAGERS LISTED ON THE HIT LIST WERE SENT HOME AND SEVERAL OTHER EMPLOYEES CHOSE TO LEAVE WORK. WASTE MANAGEMENT HIRED PHOENIX POLICE OFFICERS TO WORK IN AN OFFDUTY CAPACITY TO HELP SECURE THE BUILDING. ON JULY 11, 2017, A DETECTIVE FROM ASU POLICE VERIFIED JARRELL STEPHENS WAS CURRENTLY ENROLLED AT ARIZONA STATE UNIVERSITY AND LISTED AS HIS CURRENT CONTACT MOBILE NUMBER. AN EMERGENCY SEARCH WARRANT CONDUCTED BY PHOENIX POLICE DETECTIVE ON , REVEALED JARRELL STEPHENS ADDED AS A RESCUE EMAIL FOR HIS APPLE ACCOUNT. ON JUNE 24TH, 2017 BETWEEN 1550 AND 062617 AT 1330 HOURS, JARRELL STEPHENS COMMITTED AN INTERFERENCE WITH JUDICIAL PROCEEDINGS BY CALLING HIS VICTIM , 25 TIMES AND LEAVING AT LEAST 5 VOICE MES-SAGES THAT INCLUDED THREATS AGAINST LIFE. HAD JARRELL SERVED WITH AN ORDER OF PROTECTION ON 062417 WHICH PRECLUDES JARRELL FROM COMMUNICATING WITH IN ANY WAY. THE VOICE MESSAGES INCLUDED ACCUSATIONS THAT IS A PEDOPHILE AND THREATS TO SHOOT . ON JULY 11TH, 2017 BETWEEN 2138 HOURS AND 2143 HOURS, JARRELL STEPHENS CALLED VICTIM 27 TIMES LEAVING 5 VOICE MAILS THAT WERE VULGAR AND HARASSING. THIS ALSO VIOLATED THE OR-DER OF PROTECTION HAS AGAINST JARRELL. ON JULY 12TH, 2017 BETWEEN THE HOURS OF 2124 AND 2150 HOURS, JARRELL STEPHENS CALLED VICTIM SEVERAL MORE TIMES AND LEAVING AT LEAST 3 VOICE MAIL MESSAGES CALLING A PEDOPHILE A RAPIST AND OTHER VULGAR STATEMENTS, VIOLATING THE ORDER OF PROTECTION AGAINST HIM. VICTIM CAN IDENTIFY JARRELLS VOICE AS HE HAS KNOWN HIM FOR SEVERAL YEARS . THE VOICE MAIL MESSAGES WERE RECORDED AND SAVED FOR EVIDENCE.
