DEF WAS CONTACTED AT THE PRESIDENT TRUMP RALLY AT 100 S 4TH ST AFTER FOLLOWING AN OFFICER FOR SEVERAL MILES. HE WAS LAWFULLY ORDERED TO MOVE THE VEHICLE HE WAS DRIVING AS HE WAS BLOCKING TRAFFIC IN THE STREET. DEF ILLEGALLY PARKED HIS VEHICLE, EXITED AND CONFRONTED OFFICER. DEF EXHIBITED AGGRESSIVE MANNERISMS AND THE LONE OFFICER WAS FOLLOWED CLOSELY ACROSS THE STREET BY DEF. THREE VICTIMOFFICERS STOPPED HIM FROM TRESPASSING IN PRIVATE PARKING GARAGE AND ORDERED TO LEAVE. DEF FEIGNED A DEPARTURE AND RETURNED TO THE AREA THE THREE OFFICERS WERE LOCATED. DEF SHOULDER CHECKED ONE OFFICER AND STATED HE WOULD FUCK HIM UP. DEF DIRECTED TO LEAVE BUT THEN OFFICERS SAW HANDGUN IN RIGHT SIDE OF DEF'S WAISTBAND AND GIVEN ORDERS TO NOT TOUCH HIS GUN FOR OFFICER SAFETY. DEF DID NOT COMPLY AND PUT HAND ON GUN GRIP WHILE VERBALLY THREATENING TO KICK ONE OFFICERS ASS. OFFICERS PHYSICALLY CONTACTED DEF TO ARREST HIM. DEF WAS TOLD VERBALLY HE WAS UNDER ARREST AND ORDERED TO STOP RESISTING ARREST AND KEEP HANDS AWAY FROM HIS WEAPON. DEF THREW NUMEROUS ELBOWS AT OFFICERS TO RESIST THEIR ARREST. HE STRUCK ONE OFFICER IN THE CHEST CAUSING HIS RADIO MICROPHONE TO FLY OFF. AN OFFICER WAS ABLE TO DISARM DEF AND TOSS GUN AWAY FROM DEF WHILE SIMULTANEOUSLY STRUGGLING TO CONTROL DEF'S ACTIONS. DURING THE PHYSICAL STRUGGLE, DEF REPEATEDLY MADE ATTEMPTS TO REACH OUT FOR THE GUN. DEF USED FORCE TO PULL HANDS/ARMS FROM OFFICER GRASP AND WAS ABLE TO BREAK FREE FROM OFFICER CONTROL. DEF TAKEN INTO CUSTODY AND CONTINUED THREATS TO HARM THE OFFICER. THE FIREARM WAS RECOVERED AND FOUND TO BE A LOADED AND CHAMBERED HANDGUN.
