<u>ADDENDUM</u>

B1. Probable Cause Statement ON JUNE 16, 2017 AT APPROXIMATELY 0043 HOURS THE DEFENDANT FORCIBLY ENTERED THE WHO RESIDED AT THE OFFENSE LOCATION. THE DOOR FRAME OF THE SECURED RESIDENCE OF OFFENSE LOCATION WAS SEVERELY DAMAGED. THE DEFENDANT SHOT APPROXIMATELY THREE TIMES; ONE IN THE NECK, ONE IN THE RIGHT UPPER CHEST, AND ONE IN THE LEFT THIGH. WAS SHOT IN THE DINING ROOM AREA OF THE APARTMENT. THE VICTIMS GIRLFRIEND, IN AN ADJACENT BEDROOM AND WAS SHOT BY THE DEFENDANT APPROXIMATELY FIVE TIMES TO INCLUDE ONE IN THE TOP OF HER HEAD, ONE IN THE UPPER CENTER CHEST, ONE IN HER RIGHT ARM, ONE IN HER LEFT ARM, AND ONE IN HER LEFT LEG. THE SHOOTING PROMPTED 911 TO BE CALL; RESPONDING OFFICERS FOUND SEVERELY WOUNDED, LAYING ON THE FLOOR OF THE DINING ROOM. TOLD OFFICERS HIS EX-ROOMMATE ARTURO PEREZ SHOT HIM. TRANSPORTED TO A LOCAL HOSPITAL WHERE HE UNDERWENT MULTIPLE SURGERIES RELATED TO THE GUNSHOT WOUNDS. WHILE AT THE HOSPITAL AND PRIOR TO SURGERY, POSITIVELY IDENTIFIED THE DEFENDANT BY A PHOTO SHOWN TO HIM BY A UNIFORMED OFFICER. IDENTIFIED THE FEMALE IN THE APARTMENT AS HIS GIRLFRIEND . WAS LOCATED ON A BED IN A BEDROOM ADJACENT TO THE DINING ROOM. WAS PRONOUNCED DECEASED ON SCENE BY MESA FIRE DEPARTMENT PERSONNEL. THE SUBSEQUENT INVESTIGATION REVEALED THE DEFENDANT HAD LIVED WITH AT THE OFFENSE LOCATION FROM JANUARY 2017 TO MARCH 2017. NEW ROOMMATE STATED THERE WAS A PREVIOUS ARGUMENT BETWEEN THE DEFENDANT AND OVER A POSSIBLE INFIDELITIES WITH THE DEFENDANT'S GIRLFRIEND. AND WAS GIRLFRIEND. SEVERAL CASINGS AND PROJECTILES WERE RECOVERED FROM THE OFFENSE LOCATION. THE DEFENDANT WAS LOCATED AT HIS RESIDENCE AND TAKEN INTO CUSTODY

AT 1300 HOURS. HE WAS READ MIRANDA RIGHTS AND CONFIRMED HE DID LIVE WITH AT THE OFFENSE LOCATION IN EARLY 2017. HOWEVER, THE DEFENDANT DENIED AN ARGUMENT AND STATED HE MOVED OUT OF THE APARTMENT BECAUSE HE WANTED TO BE WITH HIS GIRLFRIEND. THE DEFENDANT DENIED BEING AT THE OFFENSE LOCATION WHEN THIS INCIDENT OCCURRED; HE STATED HE WAS AT HIS AUNT'S HOUSE DRINKING ALCOHOL WITH SEVERAL COUSINS. THE DEFENDANT ADMITTED HE KNEW BUT DENIED SHOOTING HER. INVESTIGATORS CONTACTED THE DEFENDANT'S AUNT AND SHE CLAIMED HE WAS AT HER RESIDENCE ALL NIGHT DRINKING ALCOHOL. AT THIS POINT IN THE INVESTIGATION WAS OUT OF SURGERY AND COMMUNICATING WITH INVESTIGATORS THROUGH A LETTER BOARD. CONFIRMED HIS MOTHER'S NAME, ADDRESS, AND TELEPHONE NUMBER. HE ALSO CONFIRMED SEVERAL TIMES THAT THE DEFENDANT SHOT HIM AND . THE DEFENDANT WAS CONFRONTED AGAIN ABOUT BEING AT THE OFFENSE LOCATION AND SHOOTING BOTH VICTIMS, HE DENIED SHOOTING THE VICTIMS AND CLAIMED HE WAS DRINKING WITH HIS AUNT AND COUSINS.
