## **B. PROBABLE CAUSE STATEMENT**

1. Summarize and include the facts which establish probable cause for the arrest for the crimes charged:

On the listed date and time, the Defendant was driving a motor vehicle eastbound on Broadway from Higley in Mesa, AZ. As the Defendant approached the intersection of 56th St, she attempted to proceed through the green traffic signal. A second passenger car was stopped at the intersection in the #1 lane due to a 7 year old child crossing the roadway on foot from north to south. As the Defendant entered intersection on a green light, her vehicle collided with the child. The Defendant stopped her vehicle briefly, but indicated she was afraid she had killed the child. The Defendant attempted to contact her sister in law by phone to ask what to do. When she was not able to reach her sister in law, the Defendant admitted she left the scene.

The Defendant was able to reach her brother by telephone once she reached the intersection of Sossaman and Broadway. When she advised her brother what had happned, he instructed her to return to the scene. The Defendant drove to the scene and made contact with Officers.

<u>Under Miranda, the Dendant admitted to driving the vehicle and striking the child. She acknowledged she was required to stop and remain on scene. She stated she left the scene because she panicked.</u>

The Defendant holds an Arizona learners permit and had no licensed driver in the vehicle with her.
