On October 21, 2017, at approximately 2111 hours, a five vehicle fatal collision occurred on eastbound Interstate 10 (I-10) at milepost 164.2. I, Arizona Department of Public Safety (DPS) Vehicular Crimes Unit (VCU) Detective was contacted by DPS VCU Sergeant via cellular telephone of the incident. I was request to respond to DPS Knutson Station via cellular telephone of the incident to lead the criminal investigation.

Upon my arrival, I learned the following information from DPS Highway Patrol

Lauren Tamburrelli of Chandler Arizona was identified by witnesses and admitted to driving a vehicle involved in the collision. Tamburrelli was described by several witnesses as to have an odor of alcoholic beverages coming from her person. Witnesses also described, Tamburrelli was attempting to walk away from the incident scene. Trooper contacted Tamburrelli while she was holding her daughter, later identified as

stated Tamburrelli was staggering with witnesses attempting to hold her up. Trooper Casey stated Tamburrelli was yelling at the witnesses with hostility to leave her alone.

Trooper asked Tamburrelli what happened to which she responded she was driving and now here she was. Trooper said he could smell a strong odor of alcoholic beverages coming from Tamburrelli's breath. Trooper said also noted Tamburrelli's speech was slurred, her eyes were bloodshot red, and watery. Trooper said also noted Tamburrelli for more details but instead of responding to him, she started walking away without answering. After asking again, Tamburrelli said she wanted a lawyer.

At approximately 2122 hours, Trooper placed Tamburrelli under arrest and she began having mood swing and became combative. Tamburrelli asked repetitive question of Trooper trans, repeating the same questions several times. Trooper transpisaid once Tamburrelli was placed in his back seat, the odor of alcoholic beverages became stronger, her slurred speech continued, she mispronounced common words several times, and almost vomited while she spoke to herself with incoherent sentences.

After speaking with Troopdating, 1 contacted Sergeant Haywood and received the following information from troopers and detectives on scene:

Vehicle three was side swiped by vehicle one and was occupied by driver, DOB , and passenger, DOB . , was transported to Chandler Regional Hospital for further medical attention. Vehicle four and vehicle five were traveling on the westbound lanes of the I-10 when they were struck by debris resulting from the collision sequence.

I attempted to speak to Tamburrelli and advised her of her Miranda Rights from a department issued Miranda Warnings card. She refused and requested to contact a lawyer. I exited the interview room giving Tamburrelli privacy from 2324 hours to 2354 hours and placed a phone book in her possession.

Throughout the contact with Tamburrelli, she displayed several mood swings and emotions. Tamburrelli hysterically began to cry on multiple occasions, was observed by DPS HPD Trooper attempting to pick the lock on her handcuffs with a hair pin, asked to use the restroom on more than six occasions with a two hour period, and said she needed to throw up but when asked it was not due to any medical reasons. Tamburrelli also insisted on asking questions about the incident and was unable to recall anything occurring.

The defendant has been found to be bailable as a matter of right. IT IS HEREBY ORDERED that the defendant must comply with all release conditions and shall be released from custody in this Cause Number as follows:

## Secured Appearance Bond

The defendant will deposit with the Clerk of the above Court the total sum of **\$500,000.00**, which includes all applicable surcharges.

#### **RELEASE CONDITIONS**

- 1. You are not to return to the scene of the alleged crime.
- 2. You are not to initiate contact with the alleged victim or victims.
- 3. You are not to have any physical contact with any alleged victim.
- 4. You are not to initiate contact with the alleged complainant or witness.
- 5. You are not to initiate contact with the arresting officers.
- 6. You are not to possess any drugs without a valid prescription.
- 7. You are not to possess or consume any alcohol.
- 8. You are not to drive a motor vehicle without a valid driver's license.
- 9. You must continue to provide the court with proof of your local address.
- 10. You must submit to DNA testing at the police department that arrested you within five (5) days of release from custody. You must bring proof of your DNA Testing to your next hearing. If you do not submit to testing your release will be revoked.
- 11. You must return to the police department that arrested you and have them 10-Print fingerprint you. If you are released from custody you must complete this before your next hearing. You must bring proof of your fingerprinting to your next hearing or your release may be revoked.
- 12. You may not drive any motor vehicle at any time.

You must appear at all court proceedings in this case or your release conditions can be revoked, a warrant will be issued and proceedings may go forward in your absence. You must maintain contact with your attorney. If convicted, you will be required to appear for Sentencing. If you fail to appear, you may lose your right to a direct appeal. In addition, failure to appear at a future court proceeding may result in a waiver of any claim that you were not informed of a plea offer made in your case by the State. **a**. You will appear to answer and submit to all further orders and processes of the court having jurisdiction of the case. **b**. You will refrain from committing any criminal offenses. **c**. You will diligently prosecute any appeal. **d**. You will not leave the state without permission of the court. If you violate any conditions of this release order, the court may order the bond and any security deposited in connection therewith forfeited to the State of Arizona. In addition, the court may issue a warrant for your arrest upon learning of your violation of any conditions of your release. After a hearing, if the court finds that you have not complied with the conditions of release, it may modify the conditions or revoke your release altogether.

If you are released on a felony charge, and the court finds the proof evident or the presumption great that you committed a felony during the period of release, the court must revoke your release. You may also be subject to an additional criminal charge, and upon conviction you could be punished by imprisonment in addition to the punishment which would otherwise be imposable for the crime committed during the period of release. Upon finding that you violated conditions of release, the court may also find you in contempt of court and sentence you to a term of imprisonment, a fine, or both.
