ADDENDUM

B1. Probable Cause Statement

ON JANUARY 29, 2018 AT APPROXIMATELY 1030 HOURS, PHOENIX POLICE OFFICERS WERE DISPATCHED TO A CALL OF SHOTS FIRED IN THE AREA OF FORMATION ON THE ORIGINAL CALL STATED THAT WORKERS ON EITHER SIDE OF CHAPIN AUTO , WERE HEARING GUNSHOTS BEING FIRED. WRECKING, LOCATED AT THE SAME WORKERS ALSO SAW A DARK BLUE SEDAN LEAVING THE SALVAGE YARD FOLLOWING THE GUNSHOTS. OFFICERS ARRIVED ON SCENE AND LOCATED TWO SHOOTING VICTIMS INSIDE THE CHAPIN AUTO WRECKING YARD. THE PHOENIX FIRE DEPARTMENT ARRIVED ON SCENE AND PRONOUNCED BOTH VICTIMS DECEASED. AT APPROXIMATELY 1102 HOURS, GLENDALE POLICE/ FIRE RECEIVED A 911 CALL FROM A SUBJECT SAYING HE HAD HURT SOMEONE AND OR POS-SIBLY KILLED THEM BY GUNFIRE IN THE AREA OF THE CALLER HE TOLD SAID HIS NAME WAS MANUEL AND WAS CALLING FROM THE 911 DISPATCHER HE WOULD WAIT THERE FOR THE AUTHORITIES TO ARRIVE. GLENDALE ADDRESS WHERE THEY LOCATED/DETAINED MANUEL POLICE ARRIVED AT THE OREJEL, WHO WAS STANDING IN FRONT OF APARTMENT . AT THE TIME MANUEL WAS DE-TAINED, HE HAD IN HIS POSSESSION A RED SWEATER/SWEATSHIRT, A FOLDING KNIFE, A WALLET, A SAMSUNG CELLULAR PHONE AND A PAIR OF BRASS KNUCKLES.GLENDALE OFFICERS SPOKE TO MANUELS SISTERINLAW, , WHO LIVED IN APARTMENT . SHE TOLD OFFICERS THAT MANUEL ARRIVED IN HIS BLUE MITSUBISHI THAT WAS PARKED IN THE LOT JUST NORTH OF HER APARTMENT. OFFICERS LOCATED A FOUR DOOR BLUE MITSUBISHI SEDAN, AZ , PARKED JUST NORTH. OFFICERS LOOKED INTO THE VEHICLE THROUGH THE FRONT WINDSHIELD AND SAW A SILVER COLORED REVOLVER IN PLAIN VIEW ON THE PASSENGER SEAT OF THE VEHICLE. THE VEHICLE WAS SECURED AND PHOENIX HOMICIDE INVESTIGATORS WERE CONTACTED.LEAH PROVIDED THE FOLLOWING INFORMATION TO INVEST-IGATORS. ON JANUARY 29, 2018 AT AROUND 1030 OR 1040 HOURS, RECEIVED A PHONE CALL FROM MANUEL, WHO SAID HE WAS IN THE AREA AND WAS GOING TO STOP BY HER APARTMENT. MANUEL ARRIVED A SHORT TIME LATER, KNOCKED ON DOOR AND TOLD HER THAT HE DID SOMETHING HE SHOULDNT HAVE DONE AND POSSIBLY HURT SOMEONE. RE-FUSED TO ALLOW MANUEL INTO HER HOME AND TOLD HIM TO CALL 911. ACCORDING TO MANUEL USED HIS SAMSUNG CELLULAR PHONE AND CALLED 911. WHILE HE WAS ON THE PHONE WITH THE OPERATOR, OVERHEARD MANUEL SAY THAT HE HAD POSSIBLY KILLED SOMEONE AT THE CHAPIN AUTO WRECKING YARD. SHUT AND LOCKED THE DOOR UNTIL POLICE AR-RIVED. ACCORDING TO , MANUEL HAD BEEN USING DRUGS GLASS AND WAS BECOMING MORE AND MORE PARANOID. THE PREVIOUS THURSDAY JANUARY 25, 2018, MANUEL WAS TELLING SEVERAL SUBJECTS WHO WORKED AT CHAPIN AUTO WRECKING THAT WERE FOLLOWING HIM AND TRYING TO SET HIM UP. WHEN ASKED HIM MORE ABOUT IT, MANUEL TOLD HER THAT LAST NAME UNKNOWN WERE FOLLOW-ING HIM, GIVING HIM DIRTY LOOKS AND POLLOITO AND PLANTING ITEMS INSIDE HIS VEHICLE. ACCORDING TO , MANUEL HAD MENTIONED IN PREVIOUS DISCUSSIONS, HOWEVER LAST THURSDAY, MANUEL APPEARED MORE PARANOID THAN IN THE PAST. IN THE INTERVIEW WITH MANUEL HE SAID HE HAD KNOWN THE VICTIM WHO HE CALLED FOR AWHILE. IN THE LAST MONTH THEY HAD A FEW ARGUMENTS. TODAY HE TO BRING HIM A PEACE OFFICER OF NARCOTICS, SPECIFICALLY GLASS. THEY WENT TO SEE BOTH WERE USING THE GLASS AND AFTER A SHORT WHILE SAW THE GUN IN MANUELS SWEATSHIRT POCKET AND REACHED FOR IT AND THE GUN WENT OFF. MANUEL SAID THEY WERE ANOTHER GUY OFF TO THEIR EAST BEFORE THE GUN WENT OFF. MANUEL DEMONSTRATED AFTER THE GUN WENT OFF THAT HE MOVED HIS ARM FROM OUT TO HIS RIGHT SIDE TO HIS CENTER LINE AND THE GUN CONTINUED TO GO OFF DURING THAT TIME. HE SAID HE DID NOT SEE THE MAN TO THE EAST GET SHOT, BUT WAS SHOT AND RAN TO THE NORTH. MANUEL FOLLOWED HAD FALLEN TO THE GROUND AND MANUEL TRIED TO HELP HIM GET CLOSER TO THE HIM AND WAS BEGGING HIM NOT TO KILL HIM AND THE GUN WENT OFF AGAIN. ON THE CALL TO 911 MANUEL IDENTIFIED HIMSELF AND TOLD THE 911 OFFICER THAT HE WAS SCARED SHOT BOTH OF THEM. INVESTIGATORS AT THE SCENE FOUND ON THE NORTH SIDE OF THE LOT WITH A GUNSHOT WOUND TO HIS BUTTOCKS, HIS BACK AND HIS HEAD. THE OTHER MALE VICTIM WAS FOUND TO THE EAST IN THE LOT WITH A GUNSHOT WOUND THROUGH HIS ARM INTO HIS CHEST.
