## **ADDENDUM**

## B1. Probable Cause Statement

CASE ON FEBRUARY 10TH 2013.

ON 051417 AT APPROXIMATELY 0055 HOURS PHOENIX POLICE OFFICERS RESPONDED TO THE IN PHOENIX, REFERENCE A REPORT OF A SHOOTING. UPON LOCATION OF OFFICERS ARRIVAL, THEY LOCATED AN ADULT MALE VICTIM LAYING ON THE DRIVEWAY OF THIS LOCATION. THERE WAS A LARGE WHITE HUMMER LIMOUSINE PARKED IN THE STREET DIRECTLY IN FRONT OF THIS HOUSE. OFFICERS OBSERVED ZHAIR ZAMORASEPULVEDA STAND-ING IN THE CARPORT AREA HOLDING A SPRINGFIELD ARMORY .45 CALIBER SEMI AUTO HAND-GUN. HE WAS DETAINED AT THIS TIME.DURING THE COURSE OF THE INVESTIGATION IT WAS REPORTED BY THE VICTIM AND WITNESS THAT ZHAIR AND HIS WITNESS GIRLFRIEND HAD RENTED THE LIMOUSINE FOR THE EVENING UP UNTIL MIDNIGHT. THE VICTIM WAS THE DRIVER OF THE LIMOUSINE. UPON DROPPING ZHAIR AND HIS GIRLFRIEND OFF AFTER MID-NIGHT, THE VICTIM DEMANDED FURTHER PAYMENT DUE TO THE LATER DROP OFF TIME. THE VICTIM EXITED THE VEHICLE AND CONFRONTED ZHAIR ASKING FOR MORE PAYMENT. ZHAIR WENT INSIDE HIS RESIDENCE AND CAME BACK OUT WITH THE LISTED HANDGUN AND FIRED APPROXIMATELY 5 ROUNDS TOWARDS THE GROUND AND AT THE VICTIM. THE VICTIM WAS STRUCK ONCE IN THE LEFT CALF AND ONCE IN THE RIGHT ANKLE.PHOENIX FIRE DEPARTMENT RESPONDED FOR MEDICAL ASSISTANCE AND TRANSPORTED THE VICTIM TO GOOD SAMARITAN HOSPITAL. POST MIRANDA, ZHAIR STATED HE DISCHARGED THE HANDGUN INTO THE GROUND DURING THE CONFRONTATION, AS A WARNING TO THE VICTIM. ZHAIR CLAIMED HE FELT THREATENED ALTHOUGH HE ADMITTED THE VICTIM DID NOT THREATEN OR ASSAULT HIM. ZHAIR STATED HE PURCHASED THE FIREARM APPROXIMATELY ONE MONTH AGO FOR 800 DOL-LARS.A RECORDS CHECK ON ZHAIR REVEALED HE IS A PREVIOUSLY DEPORTED FELON AND IL-LEGALLY IN THE UNITED STATES, PER I.C.E. DEPORTATION OFFICER GOBER SERIAL NUMBER 7084. ZHAIR IS A CONVICTED FELON, PER MARICOPA COUNTY SECURE DOCKET WEB SITE CR2009121726001 FOR MISCONDUCT INVOLVING WEAPONS/PROHIBITED POSSESSOR. ZHAIR AD-MITTED TO BEING BROUGHT TO THE UNTIED STATES ILLEGALLY WHEN HE WAS APPROXIMATELY 5 YEARS OLD.DURING THE COURSE OF THIS INVESTIGATION, FURTHER RECORDS WERE CHECKED INTO PAST PHOENIX POLICE DEPARTMENTAL REPORTS. IT WAS LEARNED THAT ZHAIR WAS IDENTIFIED AS BEING THE SHOOTER OF AN AGGRAVATED ASSAULT FROM 2013, REFER-ENCE 201300244497. ZHAIR WAS IDENTIFIED AS SHOOTING ANOTHER VICTIM IN THE STOM-ACH WITH A .40 CALIBER SEMI AUTO HANDGUN ON FEBRUARY 10TH 2013 IN THE AREA OF IN PHOENIX. THE VICTIM OF THIS SHOOTING WAS UNCOOPERATIVE WITH INVESTIGATORS, HOWEVER DURING THE INTERVIEW THIS MORNING ZHAIR ADMITTED, HE DID IN FACT POSSESS THE .40 CALIBER HANDGUN AND SHOOT IT AT THE 2013 VICTIM, CLAIMING IT WAS DONE IN SELFDEFENSE. THE SPENT RECOVERED .40 CALIBER CASING FROM THIS 2013 AGGRAVATED ASSAULT LINKED THROUGH NIBIN TO A 2011 SHOOTING THAT OC-CURRED DIRECTLY INFRONT OF ZHAIRS RESIDENCE. THE INFORMATION IN THE REPORT STATES THE SHOOTER MATCHES ZHAIRS PHYSICAL DESCRIPTION BUT ZHAIR DENIED FIRING HIS GUN BACK THEN. ZHAIR WAS BOOKED FOR THE AGGRAVATED ASSAULT WITH DEADLY WEAPON AND MISCONDUCT INVOLVING WEAPON/PROHIBITED POSSESSOR FROM MAY 14TH 2017 AND THE MISCONDUCT INVOLVING WEAPONS/PROHIBITED POSSESSOR VIOLATION FROM THE
