B. PROBABLE CAUSE STATEMENT

1. Summarize and include the facts which establish probable cause for the arrest for the crimes charged:

On May 17th, 2018 at 1300 hours, Winslow Police contacted Mesa Police regarding a missing person and a stolen vehicle out of Tempe. Post Miranda Tiffany made statements implicating Jesse in Joseph Trevizos murder and she knew Jesse had stolen the van. Tiffany said Jesse was jealous because Tiffany and Joseph had been flirting with each other and in order for the two of them to be together Joseph had to be murdered. According to Jesse Tiffany agreed and approximately 10 minutes later Jesse lunged at Joseph and Tiffany ran into their bedroom. Tiffany heard Joseph screaming for help and calling her name. A short time later, Tiffany emerged from the bedroom and found Joseph deceased with multiple stab wounds and a lot of blood on their living room floor. Jesse placed Josephs body on top a butterfly shower curtain he retrieved from their bathroom. Tiffany purchased cleaning supplies and when she returned they cleaned up the blood and removed the carpet. At one point, Tiffany said Josephs body was no longer in the apartment but she did not know what happened to him. Tiffany and Jesse fled in the van Jesse had

stolen from his ex employer and planned to drive to Wisconsin. Post Miranda Jesse told police Joseph was visiting he and Tiffany at their apartment located at [REDACTED] and he thought the two of them were becoming too close. Jesse formulated a plan stating the only way he and Tiffany could be together was if Joseph was murdered and Tiffany agreed. Approximately 10 minutes later, Jesse began to stab Joseph and Tiffany ran into the bedroom. A short time later, Tiffany emerged from the bedroom and Joseph was deceased on the floor. Jesse wrapped Joseph in a shower curtain and took him out to Tiffanys car. They cleaned up their apartment and took Joseph to a forest area in Star Valley, AZ and disposed of his body. They drove back to Tempe and Tiffanys vehicle broke down in the area of US 60 and Rural. The decision was made to steal his ex employers van and drive to Wisconsin. While enroute to Wisconsin they were contacted by Winslow PD. Mesa Police served a warrant at Tiffany and Jesses apartment in Mesa and with the use of chemical materials police were able to identify the apartment had been covered with blood and cleaned. Jesse told police he could show them where Josephs body was located in Star Valley. Multiple agencies responded to the area Jesse pointed out and a body was located concealed underneath some bushes and wrapped in a shower curtain and a blue blanket. The body has not been positively identified and the autopsy is pending. Jesse admitted to stabbing Jesse with a knife and that he threw the knife in his dishwasher, however it was not recovered from this location and is still outstanding. Both Tiffany and Jesse said they were each under the influence of methamphetamine they had either purchased or had been given by Joseph who is 34 years old but has a mental capacity of a 15 year old. Jesse was Josephs caretaker and his supervisor prior to his death.
