ON OR ABOUT DECEMBER 10, 2017 DEFENDANT COMMITTED CHILD ABUSE IN VIOLATION OF ARS 13-3623 B.1, A CLASS A FELONY WHEN HE CAUSED SIGNIFICANT INJURIES OVER MULTIPLE PLAINS OF THE BODY OF HIS 3 YEAR OLD FEMALE VICTIM WHILE IN SEVERAL LOCATIONS IN PHOENIX, MARICOPA COUNTY, ARIZONA.

THE VICTIM IS A 3 YEAR OLD FEMALE. THE VICITM WAS SEEN BY MEDICAL STAFF AT THE PHOENIX CHILDREN'S HOSPITAL WHERE SFIE WAS, FOUND TO HAVE MULTIPLE BRUISES ON THE FRONT AND BACK OF HER TORSO. THE VICTIM ALSO HAD A SWOLLEN AREA NEAR HER MOUTH / CHEEK. THE INITIAL MEDICAL EXAM SHOWED THE VICTIM HAD MULTIPLE BROKEN RIBS. FURTHER MEDICAL EXAMS ARE BEING COMPLETED.

THE MOM OF THE VICITM WAS INTERVIEWED AND STATED THE DEFENDANT TOOK THE CHILD FOR THE MAJORITY OF THE DAY ON DECEMBER 10, 2017. WHEN THE BEFENDANT ARRIVED HOME SHE NOTICED THE VICTIM HAD A SWOLLEN AREA NEAR HER MOUTH! CHEEK AREA. WHEN THE DEFENDANT WAS QUESTIONED ABOUT THE INJURY HE DID NOT PROVIDE A REASONABLE EXPLANATION. THE VICTIM'S MOM LATER TOOK THE VICITM TO THE PROENTS CHILDREN'S HOSPITAL. THE VICTIM'S MOM SAID VICTIM DID NOT HAVE THE INJURIES PRIOR TO HER LEAVING IN THE MORNING WITH THE DEFENDANT.

DURING A POST MIRANDA INTERVIEW THE DEFENDANT STATED HE WAS "FRUSTRATED" BECASUE THE VICTIM HAD SEVERAL ACCIDENTS IN HER PANTS AND WOULD NOT SIT STILL WHEN HE CLEANED HER. THE DEFENDANT STATED HE HELD HIS HAND OVER THE VICTIMS MOUTH WHEN SHE WAS SCREAMING DURING HER DIAPER CHANGE. THE DEFENDANT STATED HE HAD TO USE FORCE TO HOLD THE VICTIM TO CHANGE HER DAIPER AND HAD HELD HER WITH HIS HANDS. THE DEFENDANT STATED HE DID NOT MEAN TO CAUSE THE INJURIES BUT WAS FRUSTRATED.

- 11. You must continue to provide the court with proof of your local address.
- 12. You must find an alternative residence and provide proof of that residence within hours to Pretrial Services Agency.
- 13. You must obey all of the terms, conditions and requirements of any Order of Protection issued, or to be issued, and served upon you.
- 14. You must obey all of the terms, conditions and requirements of any Order Against Harassment issued, or to be issued, and served upon you.
- 15. You must submit to DNA testing at the police department that arrested you within five (5) days of release from custody. You must bring proof of your DNA Testing to your next hearing. If you do not submit to testing your release will be revoked.
- 16. You may have no contact with the alleged victim(s) for any reason, even if an alleged victim contacts you first. You may not reside at the same location as any alleged victim, even if you are an owner or renter of the residence. One civil standby with law enforcement is permitted to retrieve essential belongings.

You must appear at all court proceedings in this case or your release conditions can be revoked, a warrant will be issued and proceedings may go forward in your absence. You must maintain contact with your attorney. If convicted, you will be required to appear for Sentencing. If you fail to appear, you may lose your right to a direct appeal. In addition, failure to appear at a future court proceeding may result in a waiver of any claim that you were not informed of a plea offer made in your case by the State. a. You will appear to answer and submit to all further orders and processes of the court having jurisdiction of the case. b. You will refrain from committing any criminal offenses. c. You will diligently prosecute any appeal. d. You will not leave the state without permission of the court. If you violate any conditions of this release order, the court may order the bond and any security deposited in connection therewith forfeited to the State of Arizona. In addition, the court may issue a warrant for your arrest upon learning of your violation of any conditions of your release. After a hearing, if the court finds that you have not complied with the conditions of release, it may modify the conditions or revoke your release altogether.

If you are released on a felony charge, and the court finds the proof evident or the presumption great that you committed a felony during the period of release, the court must revoke your release. You may also be subject to an additional criminal charge, and upon conviction you could be punished by imprisonment in addition to the punishment which would otherwise be imposable for the crime committed during the period of release. Upon finding that you violated conditions of release, the court may also find you in contempt of court and sentence you to a term of imprisonment, a fine, or both.
