Probable Cause Statement ON OCTOBER 22, 2017, AT APPROXIMATELY 0800 HOURS, AZ DPS TROOPER 10200, CONDUCT3ED A TRAFFIC STOP ON A 1997 GOLD HONDA FOUR DOOR SEDAN FOR SPEED IN THE AREA OF SOUTHBOUND I-17 AND MILEPOST 244. THE VEHICLE WAS BEARING A NEW MEXICO LICENSE PLATE " ". AS THE TROOPER APPROACHED THE VEHICLE, HE WAS IN-FORMED BY OPERATIONAL COMMUNICATIONS (OPCOMM) THE VEHICLE WAS REPORTED STOLEN. TROOPER ATTEMPTED TO GIVE VERVAL COMMANDS TO THE OCCUPANTS OF THE VEHICLE. THE VEHICLE THEN FLED THE AREA HEADING SOUTH. TROOPER I PURSUED THE VEHICLE IN HIS FULLY MARKED PATROL VEHICLE WITH HIS EMERGENCY LIGHTS AND SIRENS ACTIVATED. AS THE HONDA SEDAN PASSED DPS TROOPER FULLY MARKED PATROL VEHICLE IN THE AREA OF I-17 AND MILEPOST 240, A HISPANIC MALE LEANED OUT OF THE FRONT PASSENGER WINDOW AND FIRED APPROXIMATELY ONE SHOT FROM A REVOLVED-STYLE ROOPERS CONTINUED TO PURSUE THE HONDA SEDAN. IN THE HANDGUN AT APPROXIMATE AREA OF MILEPOST 240 THROUGH 238, THE FRONT MALE PASSENGER FIRED APPROXIMATELY TWO TO FOUR MORE SHOTS AT THE PURSUING TROOP-ERS, STRIKING ONE OF THEIR PATROL VEHICLES. TROOPERS PURSUED THE VEHICLE SOUTH ON I-17 TO THE STATE ROUTE 303. THE VEHICLE EXITED, THEN RE-ENTERED THE I-17 AND HEADED NORTHBOUND UNTIL THE VEHICLE SUDDENLY EXITED AT CAREFREE HIGHWAY. THE HONDA SEDAN HEADED EAST AND TROOPERS LOST SIGHT OF THE VEHICLE. THE VEHICLE WAS LOCATED ABANDONED IN THE BACK OF THE ALBERTSONS GROCERY STORE LOCATED AT 3130 WEST CAREFREE HIGHWAY, PHOENIX, ARIZONA, AND SECURED IN THE SAME LOCATION. VIDEO CAMERA FOOTAGE OBTAINED FROM DESERT DONUTS LOCATED NEXT TO THE ALBERTSONS SHOWED A FEMALE SUBJECT EXITING THE FRONT DRIVER SEAT OF THE SEDAN. THE VIDEO ALSO SHOWED A HISPANIC MALE EXITING THE FRONT PASSENGER SEAT OF THE SEDAN WITH A HANDGUN IN HIS RIGHT HAND. BOTH SUBJECTS FLED THE AREA. A WITNESS AT THE 4 SONS FOOD STORES LOCATED AT TATED A MALE MATCHING THE DE-SCRIPTION OF THE MALE SUBJECT THAT FLED THE SEDAN CONFRONTED HER AND OFFERED HER ONE MILLION DOLLARS TO DRIVE HIM OUT OF THE AREA. THE WITNESS REFUSED AND WAS ABLE TO CAPTURE A PICTURE OF THE MALE WITH HER CELL PHONE AND PROVIDED THE PIC-TURE TO TROOPERS. ADDITIONAL WITNESSES OBSERVED THE MALE AND FEMALE SUBJECT ENTER THE HOT BAGELS AND DELI RESTAURANT PHOENIX, ARIZONA. THE MALE WAS OBSERVED CARRYING A BACKPACK. AT APPROX-IMATELY 0904 HOURS, BOTH THE MALE AND FEMALE SUBJECT WERE TAKEN INTO CUSTODY BY MARICOPA COUNTY SHERIFF'S OFFICE DEPUTIES. SEVERAL WITNESSES FROM THE 4 SONS FOOD STORE WERE BROUGHT TO THE FRONT OF THE DELI AND POSITIVELY IDENTIFIED THE TWO AS THE SUBJECTS THAT APPROACHED THEM ASKING FOR RIDES. BOTH SUBJECTS ALSO FIT THE DESCRIPTION OF THE SUBJECT SEEN FLEEING FROM THE HONDA SEDAN IN THE BACK OF THE ALBERTSONS. THE MALE SUBJECT WAS LATER IDENTIFIED AS RAY RUDY SAUCEDO WITH A DATE THE FEMALE SUBJECT WAS IDENTIFIED AS TIFFANY AVALOS WITH
