



ADDENDUM FOR 2018-11332

On March 21st, 2018, at 8:38pm, [redacted], Principal of the Las Brisas Academy, located at 18211 W. Las Brisas Drive Goodyear, AZ 85338, called Goodyear Police to report allegations of child molestation between a 13 year-old male student and a female teacher identified as 27 year-old Brittany Ann Zamora.

Mrs. Zamora has been employed at this school for less than one year as a 6th grade school teacher.

[redacted] told police earlier in the evening; he was contacted by the victim's father who reported his son had been involved in an on-going sexual relationship with Mrs. Zamora. The victim's parents found sexually explicit text messages on his son's phone showing a sexual relationship between the victim and Zamora.

After officers took their initial report, it was learned the victim's father made another report on March 22nd, 2018 at 11:15pm through the Buckeye Police Department reference Mrs. Zamora and her husband, [redacted] harassing him over the phone. According to the Buckeye Police report (DR18-0321138), the victim's father stated he received a phone call from Mrs. Zamora and [redacted] who allegedly were pleading with him to not contact the police. During that phone call, [redacted] got on the phone and told the victim's father that Zamora made a big mistake, but that she loved the kids. [redacted] also pleaded with the victim's father to not call the police and asked that they handle this informally. He suggested they "meet up" and "settle this." The victim's father declined and hung up the phone.

Goodyear investigators cross-referenced the phone number through a law enforcement database and confirmed the phone number belonged to Mrs. Zamora.

Goodyear investigators contacted the victim's parents and confirmed they were alerted to sexual messages to and from the son's phone and Mrs. Zamora using a parental app.

The messages that the parents located from Mrs. Zamora to their son via "Instagram", included words like "baby" and [redacted]. When the parents looked at the messages, it showed her son and Mrs. Zamora saying they missed each other and "ily" (I Love You). The victim even says her name when saying [redacted].

Once the parents learned this information, the victim disclosed to the parents that he received a [redacted] from Zamora in the class on 3/8/18 and that sexual acts were committed in Zamora's vehicle at a grandparents address in Tolleson, later determined to be in the month of February. The victim's father, then started having the victim message Zamora and asked him to talk to Zamora the way he normally does. The conversation went as follows:

VICTIM: "I want to [redacted] so bad bby those time weren't enough for me"

MRS. ZAMORA: "I know baby! I want you every day with no time limit"

MRS. ZAMORA: "if I could quit my job and [redacted] you all day I would"

VICTIM: "I need more [redacted] from u"

MRS. ZAMORA: "I'll give you whatever you want baby."

Goodyear investigators viewed the messages and seized the cellphone pending a search warrant. This search warrant, in part, will authorize the forensic examination of the victim's phone.

On March 22, 2018, the victim's parents agreed to conduct a one-party consent call to Mrs. Zamora.

During that call, Mrs. Zamora apologized and said she was sorry. She agreed to quit her job immediately and said she had ruined her life and marriage. She said it would never happen again.

Zamora never actually said she had sex with the victim, but rather assured the parents that she was not pregnant and

could not go into details over the phone. When asked how she knew she was not pregnant, she said she was on birth control. When asked if the victim went inside her, she said no. When asked how she knew this, she said she didn't see anything and the victim didn't say anything. When asked about STDs, she said she was very clean and there was nothing to worry about.

She apologized and said she "ruined" her life and did not want to go to prison for 25 years and did not want to discuss the details on the phone because he could be recording. Zamora did state that she was the adult and the responsible one, but she wanted the victim's father to know that nothing was ever forced against the victim's will.

Zamora confirmed the name a witness student and said he was the only witness. When asked if any of this could be on camera, she said no and she knew this because there were only cameras in the hallway and outside of the school.

When the victim's father asked Zamora about a picture she sent to the victim (he stated he knew about her birthmark), she admitted to sending a picture to the victim, but wouldn't go into detail.

Shortly after the phone call, Mrs. Zamora was arrested without incident during a traffic stop. She was operating a maroon 2007 Mazda M6S registered to her. The vehicle was impounded and towed to Goodyear Police pending a search warrant. At the time of the arrest, Mrs. Zamora's cellphone was inside the car.

Zamora did not give a statement when interviewed.

A forensic interview was conducted with the victim, who disclosed three separate occasions where he had sexual intercourse (penis/vagina) with Zamora, 2 occasions where he performed oral sex on Zamora and three occasions where she performed oral sex on him. The sexual intercourse locations were consistent with what the parents had said the victim disclosed to them. He said these occurred either in Zamora's older "blackish purple" vehicle with a "teachers license plate" or in the classroom. He described two specific times where there was touching in the classroom. Once she touched his penis over his clothing and once she moved her skirt aside inviting him to, in which he did, touch her vagina with his hand under her underwear.

The victim said their relationship started when he began communicating with Zamora on a classroom chat group. He said Zamora started flirting with him, ultimately sent him naked photographs of her vagina and one of her wearing lingerie where her breasts were visible and also showed her vagina. The victim admitted to sending Zamora pictures of his penis.

All of the above described events took place between approximately 2/1/18 and 3/8/18.

The victim said that Zamora has a brownish birthmark in area of her genital, buttocks, and/or thigh area.

The victim advised that there was one victim/witness student who observed some of the incidents.

After obtaining a search warrant, which included nude photographs of Zamora, a birthmark was observed in the area described by the victim. Also located in the search warrant, was a one-piece lingerie which would reveal Zamora's breasts and vagina as they were "crotchless" bottoms and a see through top. This was as described by the victim.

On 3/22/18, I made phone contact with the parent of the other victim/witness student, who advised that her son disclosed to her today that he had recently observed Zamora having sex with the victim. The witness/victim also disclosed that Zamora had showed him naked pictures of genitals as well.
