On 9/26/17 at about 1340 hrs, [REDACTED] was arrested for possession of a handgun while at Santan Junior High School. [REDACTED] was subsequently booked into Mesa S/E Juvenile Facility.

On 9/26/17, I received a phone call from Dr. Craig Gilbert (CUSD Assistant Superintendent) in regards to a student that was found to have a gun in his backpack at Santan Junior High School. Gilbert said he didn't have alot of other information at the time. I immediately responded to Santan and upon my arrival, I met Principal Barbara Kowalinski in the front office. Kowalinski brought me into a smaller office and pointed to a stack of paperwork on the desk and told me the gun was under the papers. I removed the papers and observed a snub nose revolver and a box of ammunition next to it. Upon closer examination, the gun was a .22LR and the box of ammunition was also .22LR. The gun was not loaded at the time. I seized the gun, put it into a manilia envelope and secured it in my patrol car and then returned to the inside of the school. Kowalinski then told me the student that had the gun was in the next office with Mary Ann Rezzonico.

We entered the office and I had [REDACTED] stand up and place his hands on his head. I searched him and then handcuffed his hands behind his back and double locked the cuffs as is standard procedure. I then escorted [REDACTED] to the SRO Office in the school. At this point, Sgt. Howarth #S60 arrived and watched [REDACTED] while I conducted interviews with witnesses.

I then spoke to Kowalinski about what happened. Kowalinski said another student named [REDACTED] reported to her that [REDACTED] had a gun in his backpack. Apparently [REDACTED] was playing tag with another student and they were shoving each other. Kowalinski said that [REDACTED] told her that [REDACTED] had wispered to him that he had a gun in his backpack. [REDACTED] reported that [REDACTED] was upset over the game of tag. (See school written report by [REDACTED]). Kowalinski said she then had [REDACTED] brought up to the office and had possession of his bag. Kowalinski said she asked [REDACTED] if he had a gun in his backpack and [REDACTED] said he didn't have anything in his bag. Kowalinski said Rezzonico was present in the office and then opened the front pouch of his backpack and the gun and bullets were in there. Kowalinski said she did not open the cylinder or check to see if the gun was loaded. She took it out of the bag just the way it was found. See BWC Footage for complete

Next I spoke to Mary Ann Rezzonico who told me the following: Rezzonico said Rezzonico said Kowalinski asked her to come to the other office while they searched [REDACTED]. Rezzonico said the first pouch on the backpack she opened contained the gun and box of ammo. Rezzonico said she didn't touch the gun or manipulate it in anyway. Rezzonico said they then brought the backpack to another office (Kim's, the first one I contacted them in) and Kowalinski removed the gun and ammo and put it on the desk. Rezzonico said she didn't talk to [REDACTED] about the incident, she just had him write a statement regarding what happened today. (See attached statement by [REDACTED] [REDACTED]) See BWC Footage for complete interview.

[REDACTED] wrote in his statement: "I got it from a safe in my dads garage. I didn't want to lose my gun and I put it in my backpache. My dad was going to sell it."

[REDACTED] was then transported to the CPD Main Station and placed in a juvenile holding cell for a few minutes while I contacted his parents on the phone. Once Daniel [REDACTED] was contacted and stated he was on the way, I brought [REDACTED] up to the CIS Interview Rooms and waited to Daniel to arrive.

Once Daniel [REDACTED] arrived, I advised him of what was going on and he advised that hs son would not be making any statement today. We went into the interview room, I read [REDACTED] his juvenile miranda rights from the standard form. [REDACTED] said he understood them and signed the form indicating the same. Under advise from his father, [REDACTED] refused to answer any questions.
