The Grand Jurors of Maricopa County, Arizona, accuse ROBERT ANTHONY RESENDIZ, on December 28, 2017, charging that in Maricopa County, Arizona:

COUNT 1:

ROBERT ANTHONY RESENDIZ, on or about December 19, 2017, acting either alone or with one or more other persons, committed or attempted to commit Child Abuse, the victim being under the age of fifteen, A.R.S. §13-3623, and in the course of and in furtherance of such offense, or immediate flight from such offense, ROBERT ANTHONY RESENDIZ or another person did cause the death of Victim A, in violation of A.R.S. §§ 13-1101, 13-1105, 13-3601, 13-701, 13-702, 13-751, 13-752 and 13-801.

COUNT 2:

ROBERT ANTHONY RESENDIZ, on or about December 19, 2017, under circumstances likely to produce death or serious physical injury, and while having the care or custody of Victim A, a child under fifteen years of age, intentionally or knowingly did cause or permit Victim A's person or health to be injured or did cause or permit Victim A, to be placed in a situation where his's person or health was endangered, in violation of A.R.S. §§ 13-3623(A)(C)(F), 13-3601, 13-705, 13-701, 13-702, and 13-801.

COUNT 3:


ROBERT ANTHONY RESENDIZ, on or between November 1, 2017 and December 19, 2017, under circumstances other than those likely to produce death or serious physical injury, intentionally or knowingly did cause Victim A, a child, to suffer physical injury or abuse, to wit: first bite mark, in violation of A.R.S. §§ 13-3623(B)(C)(F), 13-3601, 13-701, 13-702, and 13-801.

COUNT 4:


ROBERT ANTHONY RESENDIZ, on or between November 1, 2017 and December 19, 2017, under circumstances other than those likely to produce death or serious physical injury, intentionally or knowingly did cause Victim A, a child, to suffer physical injury or abuse, to wit: second bite mark, in violation of A.R.S. §§ 13-3623(B)(C)(F), 13-3601, 13-701, 13-702, and 13-801.
