ON 07-11-2018 AT 1835 HOURS TROOPER STRADDLING AND I WERE PATROLLING IN THE HOV LANE NORTHBOUND SR-51 AT MP1 IN AN UNMARKED DEPARTMENT YELLOW FORD MUSTANG. WE PASSED A BLACK DODGE CHARGER IN THE NUMBER THREE LANE WITH DARK WINDOW TINT, A SPOT LIGHT AND PUSH BUMPER THAT MADE IT RESEMBLE AN UNMARKED POLICE CAR. THE BLACK DODGE CHARGER QUICKLY SPED UP BEHIND US AND ACTIVATED RED AND BLUE POLICE/EMERGENCY LIGHTS FOR APPROXIMATELY 3 SECONDS. WE MOVED TO THE RIGHT LANE AND SLOWED DOWN. THE BLACK DODGE CHARGER PULLED ALONG SIDE US IN THE HOV LANE AND WAS POINTING AT US, IT APPEARED HE WAS WEARING SOME SORT OF POLICE UNIFORM. AS THE BLACK DODGE CHARGER PASSED US WE PULLED IN BEHIND IT AND CONDUCTED A TRAFFIC STOP ON THE VEHICLE. THE VEHICLE YIELDED TO THE RIGHT. I APPROACHED THE VEHICLE FROM THE PASSENGER SIDE. THE DRIVER WAS WEARING A BLUE STEEL SECURITY UNIFORM WITH SERGEANT STRIPES. THE DRIVER WAS ALSO WEARING A POLICE STYLE GUNBELT WITH CONTAINING A GLOCK MODEL 19, 9MM HANDGUN, HANDCUFFS, PEPPER SPRAY. IN THE VEHICLE WERE MULTIPLE POLICE STYLE LIGHTS, A SIREN BOX, A POLICE STYLE RADIO/SCANNER, A TACTICAL POLICE STYLE VEST WITH A BATON, POLICE STYLE RADIO AND KNIFE. THE DRIVER WAS IDENTIFIED AS MATTHEW DISBRO BY HIS ARIZONA DRIVER'S LICENSE. I PLACED DISBRO UNDER ARREST. DISBRO WAS TRANSPORTED TO THE KNUITSON STATION WHERE HE WAS INTERVIEWED. DURING THE INTERVIEW DISBRO SAID HE INTENTIONALLY TURNED HIS RED AND BLUE LIGHTS ON TO GET US TO SLOW DOWN BECAUSE HE THOUGHT WE WERE DRIVING TOO FAST. DISBRO WAS TURNED OVER TO MCSO BOOKING STAFF. THE VEHICLE AND PROPERTY WERE SECURED AT DPS PROPERTY AND EVIDENCE.
