**COMMENTS OF THE CALL**

The comments of the call stated there were 4 employees inside. Incognito made an unknown hand gesture at one of them and said he was going to kill everyone inside. Incognito told the director he had guns in his truck, but they had not seen any. The reporting party was unable to talk because Incognito was in the room and he did not know police had been called. He was walking around the business looking for the director. The RP was afraid to leave the business and didn't want to escalate him.

Incognito was described as a white male, 35 years old, 6'05, 315 pounds, and heavily tattooed. He was seen wearing a red baseball hat, short sleeve shirt, and short.

**ARRIVAL**

Ofc Lerma-Trillo #1460 was already on scene and had one victim outside. Ofc Klay #1483 and I arrived together. I had the victim move behind our patrol vehicles and went inside too look for Incognito.

**INITIAL CONTACT**

We entered the front doors and walked a few feet inside. A white male, matching the description given by the RP, walked around the corner with his arms in the air. He began to kneel on the ground. He was given commands to lie down on the ground. He did so with no issues.

Ofc Lerma-Trillo and Ofc Klay detained Incognito by using 2 sets of handcuffs. He was handcuffed to the rear and the cuffs were double locked.

Incognito verbally identified himself and his AZ DL confirmed he was Richard Incognito.

I then separated each employee for interviews.

**VICTIM [REDACTED] INTERVIEW**

I spoke with [REDACTED] told me the following:

Richard Incognito's father had passed away and he was at that mortuary. [REDACTED] said the family had advised him Incognito was not going to be allowed to attend the funeral and he had been acting erratically. He was supposed to sign the cremation paper work with his brother, but [REDACTED] was told Incognito would not cooperate with that.

On this day he had just finished eating lunch when he heard someone in the front lobby area. He walked into the lobby and saw Richard Incognito talking with his co-worker, [REDACTED] said Incognito was talking about a lot of random things that didn't make sense. He said he wanted them to cut his dad's head off for research purposes.

[REDACTED] said Incognito walked around the funeral home, punching caskets and throwing things. He went into the office, grabbed a chair, sat down, and made himself comfortable. He said he wanted to buy flowers for the funeral and said he would buy everything they had. He gave them his credit card.

Incognito signed cremation paperwork, but then said he wanted his dad buried and wanted to look at caskets.

It was difficult to interview [REDACTED] He was visibly shaken up. He was unable to sit still or hold his hands still. He told me multiple times how upset he was. He said he thought Incognito was going to kill him.

██████████ said he was alone with incognito at one point. Incognito used one hand to make the shape of a gun. He used his pointer finger, middle finger, and thumb as the gun. He pointed it at ██████████ and told him he had a truck full of guns and asked if he wanted to see them. He then told him to stay where he was and exited the building.

██████████ ran down to the prep room because it was a secured room and he knew he'd be safe. ██████████ was already down there. They both felt safe there, but then realized there were still two female employees upstairs.

When they went back upstairs, Incognito had brought a box full of his dad's property inside. He laid it all out on a table. Police arrived a short time later.

VICTIM ██████████ INTERVIEW

I then brought ██████████ to a meeting room. He told me the following:

On this day, ██████████ was about to eat lunch when he heard the front door chime, which indicated someone had entered the building. He walked out to the front lobby area and saw a large white male speaking with ██████████ another employee. ██████████ said he recognized the subject right away as Richard Incognito. He said Incognito's dad was at the mortuary and they expected him to come by. He also said he knew it was Incognito because of how big he was.

██████████ approached Incognito, who introduced himself and shook his hand. Incognito began asking ██████████ did he need to do as far as planning the funeral and started telling him how he wanted it to go. ██████████ said ██████████ then arrived in the lobby and Incognito also greeted him. ██████████ said he didn't see what Incognito did to ██████████ but he looked back and saw ██████████ eyes were large with surprise.

They all then walked into the officer, where clients are not supposed to go. ██████████ said Incognito saw the funeral was scheduled for Friday.

He said he wanted to pick out flowers, so they took Incognito into another room to go over flowers. ██████████ said Incognito gave him his credit card and told him he wanted to buy everything they had. Incognito changed direction again and said he wanted to pick out a casket. He wanted the best one they had. ██████████ took him into the casket room and showed him the military casket. He talked about how his dad and he both served in the military and they didn't know anything about that. Incognito said he wanted that one. He then picked up an urn from a shelf over head and slammed it down on top of the caske ██████████ said there could be damage, but he wasn't sure.

Incognito then wanted to see his dad and started crying. [REDACTED] went down stairs into a prep room to get his dad ready for viewing. Incognito was left with Wells.

While down stairs, the business line began ringing and he saw an outgoing 911 call was being made. [REDACTED] did he knew one of the girls was calling 911 and he grew concerned.

[REDACTED] came down stairs a short time later and was extremely upset. He wasn't sure exactly what was said, but thought [REDACTED] had been threatened somehow and a gun was mentioned. They both then went back upstairs to be with the other two employees.

Police arrived a short time later.

**ARREST**

Ofc Lerma-Trillo arrested Incognito at approximately 1543 hours. A detention van arrived some time later and transported Incognito the D2 Jail where he was booked in and held in custody. Ofc Lerma-Trillo followed the van to the jail.

Once at the D2 Jail, Ofc Owens #1419 served Incognito a trespass warning.

I later had [REDACTED] walk me through the route they took with Incognito and go over the incident again.

Incognito entered through the front door. [REDACTED] said when he shook Incognito's hand, he pulled [REDACTED] forward and 'chest bumped him'. They then went into the office.

Incognito "made himself comfortable" and sat down in an office chair. He looked at their schedule on the wall, which was a white board with erasable markers. Incognito saw his dad's funeral on the schedule for Friday and then said his dad's name was not Incognito. He erased the name and wrote, 'Dejasa' and said that was his dad's name. He then wanted to plan the flower arrangements and they escorted him out. As they walked out, Incognito punched the printer.

They walked into Santa Rosa Conference room. Once in the room, Incognito threw his credit card at [REDACTED] and told him he

Incognito's vehicle was parked out in front of the business. He had the keys on his person when he was arrested. Due to the statements he made to employees and to officers on scene, the vehicle was towed for evidence to the D3 station. Ofc Meyer #1450 followed the vehicle to D3.

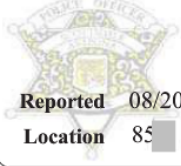

### Supplement Notes

On 08/20/2018 at approximately 1530 hours I was dispatched to the Messingers Funeral Home reference a subject, identified as Richie Incognito, threatening employee's and being disruptive. Richie's truck, identified as a Ford Raptor pickup truck, was parked outside and that he had told staff there were guns inside the vehicle. Furthermore, that he was related to an incident that occurred at 1400 hours where he was being disruptive with employees at a restaurant. Incognito was described as wearing a red hat, short sleeves, and shorts. I arrived in a fully marked patrol vehicle, wearing a regulation blue uniform, and in a fully marked patrol vehicle.

Messingers is a funeral home located at on the south side of East Pinnacle Peak Road. Its parking lot wraps around the buildings east, south, and west sides. Upon arrival I parked my patrol vehicle on the south side of the parking lot and just east of the main entrance. Officer Carlucci #1348, and Officer Lerma-Trillo #1460 were also on scene.

I, along with officers on scene, quickly moved to the main entrance of Messingers. At the entry way I noted a parlor to the right, a hallway to the left, and a long hallway straight ahead. At the far end of the hallway immediately in front of me was a male, matching the description of Richie Incognito, upon seeing police he immediately laid face down on the floor. I quickly approached him and assisted Officer Lerma-Trillo in placing handcuffs on him. The individual, who verbally identified himself as Richard Incognito Jr. was complaint throughout handcuffing. Once handcuffs were secured we then brought him to a seated position on the floor.

Incognito appeared to lack concentration and was unable to maintain a coherent thought, rather, he appeared to ramble about numerous things that did not correlate. He also stated that he had a rifle and pistol in his truck while speaking about others things, such as his belief in Homeopathic medicine and his family. Furthermore, his moods were erratic as he would be very respectful towards officer at one point, and immediately raise his voice and demand to be let out of the handcuffs the next.

I remained on scene with Officer Lerma-Trillo as a procedural backup unit while other officers conducted their investigation.

She opened the door for Incognito who said he immediately was in her space. [REDACTED] said Incognito began talking nonsense while continuing to be looming over her. [REDACTED] said she felt threatened by Incognito in his words and actions. [REDACTED] said Incognito had handed her his identification when he entered. [REDACTED] said her manager came up and she then turned and went back into the office. I asked [REDACTED] if she would be willing to prosecute Incognito and she said she would aid in prosecution.

I then spoke with [REDACTED] who works in the office. [REDACTED] said she observed Incognito come into the back office and begin looking around. [REDACTED] said she was on 911 and stopped talking to the operator when he entered the office. [REDACTED] said she was not threatened by Incognito directly but did feel nervous.

WM..35YO..605..315..HEAVILY TAT'D. LOOKING FOR JAMES [REDACTED] . RED BBCAP, SHORT SLEEVE SHIRT, SHORTS. STILL IN THE BLDG.

RP NOT COMFORTABLE IN LEAVING THE BUSN SHE IS AFRAID TO ESCALATE HIM. SHE ISNT ABLE TO TALK AGAIN. HE IS STILL INSIDE THE BUSN. RP DISC

Upon arrival to the business I observed what was identified as Richard's vehicle, identified as a Ford Raptor pickup truck which I confirmed to be unoccupied. It was parked outside the entrance of the business and it was advised that there were guns inside the truck. Please note that this was confirmed to be related to an incident that occurred at approximately 1400 hours at another business called [REDACTED] where he was being disruptive with employees.

I parked my patrol vehicle just southeast corner from the entrance approximately 100 feet away from Richard's truck and waited for Officer Carlucci #1348, and Officer S. Klay #1483 to arrive on scene.

I proceeded to move to the main entrance of Messingers where I was contacted by [REDACTED] of the business as he came outside, he was identified as [REDACTED] I observed him to be scared and appeared to be extremely nervous. I had him walk away from the entrance towards other arriving units on scene, he did so.

Officer Klay and I, then made entry inside the business through the front door of the business where I was able to see down a hall directly in front of me a male subject matching the description of Richie Incognito. I drew my handgun out due to the call comments stating that he owned firearms, as I walked towards Richard he stopped, raised his hands and laid face down on the floor. I quickly approached him and told him not to move, he complied.

At approximately 1537 hours, I detained Richard with double handcuffs to the rear and double locked with Officer Klay's assistance. He verbally identified himself as Richie Incognito Jr. as he complained during the handcuffing. Once he was handcuffed we sat him up into a seated position on the floor. stop from doing so, he complied.

While speaking with Richard he stated that he was here for his father's funeral. I asked him where his dad was, he said he was downstairs and was there to get his father's belongings. I asked him if he had any weapons in his truck, he said yes and that he had all necessary permits. He stated that he had a .45 caliber handgun with a silencer and a rifle. Please note that while speaking with Richard he demonstrated erratic non-coherent behavior as he would be compliant; however, would immediately become confrontational.

It was advised by Officer Carlucci that prosecution was desired against Richard. At approximately 1543 hours, I advised Richard that he was under arrest for disorderly conduct.

At approximately 1544 hours, I read Richard his Miranda Warning Rights verbatim from my Scottsdale PD issued card. I asked him if he understood, he stated that he did.

I remained on scene with Officer Klay while other officers on scene conducted their investigations.

Richard was transported by detention staff to district 2 jail located at 3700 N. 75th St in Scottsdale, AZ where he was booked and held in custody.
